I certify that I am fully aware of and expressly assume all risks involved in scuba diving, snorkeling, boating and all other top side activities.

I understand and agree that neither Dive N' Surf Inc., its' Employees, Dive N' Surf Dive Team, nor International PADI, Inc. nor its affiliate or subsidiary corporations, nor the owners, officers, employees, agents, contractors or assigns of the above listed entities (hereinafter referred to as "Released Parties") may be held liable or responsible in any way for any injury, death or other damages to me my family, estate, heirs or assigns that may occur as a result of my participation in this trip or as a result of the negligence of any party, including the Released Parties, whether passive or active.

I further state that I am of lawful age and legally competent to sign this Liability Release Agreement, or that I have obtained the written consent of my parent or guardian.
